2. All amounts due to Seller are payable in accordance with the payment terms granted by Seller's credit department from which the goods and services are delivered. If any amount due to Seller is not paid in accordance with such payment terms, a delinquency charge shall be added to the sum due. Which shall equal the amount obtained by multiplying the delinquent balance by a) 2% (two percent) Per Month or b) the maximum lawful rate permitted to be charged under applicable state laws.
3. Guarantor shall pay Seller a) \$ 30.00 (thirty dollars) or b) 5% (five percent) of the check balance for all checks returned by Guarantor's Bank. Provided, however that such service charge shall not be due and payable in the event such payment would result in the violation of the applicable jurisdiction.
4. In the event the account is turned over to an attorney or other agency for collection or suit is brought on same, or the same is collected through any judicial proceeding whatsoever. Guarantor shall pay cost associated with purchaser's account, including but not limited to, reasonable attorney's fees, court cost, liquidated damages, and the amount charged by collection agency for its collection services.
